

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Dr. Alberto Siquieros as the Executive
Director of the Nation's Department of Education)

RESOLUTION NO. 17-071

1 **WHEREAS, Article VII, Section 2(e) of the Constitution of the Tohono O'odham Nation vests**
2 **the Nation's chairperson with authority to appoint the Nation's treasurer, and**
3 **other officers and heads of all governmental departments with the approval of**
4 **the Tohono O'odham Legislative Council; and**

5 **WHEREAS, Chairman Edward Manuel has appointed Dr. Alberto Siquieros as the Executive**
6 **Director of the Nation's Department of Education, subject to Council approval;**
7 **and**

8 **WHEREAS, pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono**
9 **O'odham Legislative Council, the chairperson's "appointee to the position of**
10 **treasurer or other officers or heads of governmental departments shall not be**
11 **added to any Legislative Council session agenda for approval unless the**
12 **appropriate legislative committee interviews the appointee after receiving a**
13 **resume and written background investigation report" containing detailed**
14 **employment, education, credit, litigation, and other information necessary to**
15 **determine the appointee's qualifications and fitness; and**

16 **WHEREAS, the Legislative Council Human Resources Development Committee has received**
17 **and reviewed the detailed written background investigation report required by**
18 **the Legislative Rules and interviewed Dr. Siquieros.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **appointment of Dr. Alberto Siquieros as the Executive Director of the Nation's**
21 **Department of Education, and Dr. Siquieros shall serve until replaced at the**
22 **request of the Nation's chairperson.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
24 **day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 1,794.4 FOR;**
25 **1,227.0 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the**
26 **Council by Article VII, Section 2 (e) of the Constitution of the Tohono O'odham Nation, adopted**
27 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
29 **Act of June 18, 1934 (48 Stat.984).**
