

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting U.S. Department of Health and Human Services Family Violence
Prevention and Services Act Grant and Approving FY 2017 Tohono O'odham
Department of Health and Human Services Family Violence Prevention Budget)**

RESOLUTION NO. 17-081

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Department of Health and Human Services ("TODHHS")**
8 **submitted an application for a U.S. Department of Health and Human Services,**
9 **Family Violence Prevention and Services Act Grant to support emergency shelter**
10 **and supportive services for victims of domestic violence and their dependents;**
11 **and**

12 **WHEREAS, the Tohono O'odham Nation received a Family Violence Prevention and Services**
13 **Act Grant award in the amount of \$74,304.00 for the period of October 1, 2015 to**
14 **September 30, 2017; and**

15 **WHEREAS, the TODHHS prepared and submitted for review and approval its FY 2017 Family**
16 **Violence Prevention Budget, which is incorporated by this reference, in the**
17 **amount of \$74,304.00 to be funded by the Nation's General Fund pending**
18 **reimbursement from the U.S. Department of Health and Human Services; and**

19 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
20 **reviewed the FY 2017 TODHHS Family Violence Prevention Budget and**
21 **recommend its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**
23 **U.S. Department of Health and Human Services, Family Violence Prevention and**
24 **Services Act Grant for \$74,304.00 and approves the FY 2017 TODHHS Family**
25 **Violence Prevention Budget, effective October 1, 2016, in the amount of**
26 **\$74,304.00 that shall be funded by the Nation's General Fund pending**
27 **reimbursement from the U.S. Department of Health and Human Services for the**
28 **continuation of this grant.**

1 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council authorizes the Tohono
2 O'odham Nation chairperson or any designated official to administer and expend
3 the FY 2017 TODHHS Family Violence Prevention Budget provided, however, that
4 any amendments or modifications shall be submitted to the Tohono O'odham
5 Legislative Council for prior approval.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH day
7 of MARCH, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-
8 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
9 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
10 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
11 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
12 18, 1934 (48 Stat.984).


