

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care San Simon Purchased
Referred Care Budget Amendment No. 1)

RESOLUTION NO. 17-082

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC") San Simon**
8 **Purchased Referred Care Budget in the amount of \$74,495.22 was approved by**
9 **Resolution No. 16-524; and**

10 **WHEREAS, the San Simon Purchased Referred Care has prepared and submitted for review**
11 **and approval its FY 2017 Budget Amendment No. 1, which is incorporated by this**
12 **reference and which will (1) adjust personnel and operational line items; and (2)**
13 **decrease to the Indirect cost; and**

14 **WHEREAS, the FY 2017 TONHC San Simon Purchased Referred Care Budget Amendment No.**
15 **1 will decrease the FY 2017 TONHC San Simon Purchased Referred Care Budget**
16 **by \$2,929.86 from \$74,495.22 to \$71,565.36; and**

17 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
18 **reviewed the FY 2017 TONHC San Simon Purchased Referred Care Budget**
19 **Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2017 TONHC San Simon Purchased Referred Care Budget Amendment No. 1,**
22 **which includes a \$2,929.86 decrease from \$74,495.22 to \$71,565.36 based on a**
23 **decrease to the Indirect cost.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
25 **O'odham Nation chairperson or any designated official is authorized to**
26 **administer and expend the FY 2017 TONHC San Simon Purchased Referred Care**
27 **Budget as amended, provided however, that any amendments or modifications**
28 **shall be submitted to the Tohono O'odham Legislative Council for prior**
29 **approval.**
