

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care San Simon Medical
Records Program Budget Amendment No. 1)**

RESOLUTION NO. 17-083

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC"), San Simon Medical**
8 **Records Program Budget in the amount of \$321,577.92 was approved by**
9 **Resolution No. 16-524; and**

10 **WHEREAS, the TONHC has prepared and submitted for review and approval its FY 2017 San**
11 **Simon Medical Records Program Budget Amendment No. 1, which is**
12 **incorporated by this reference, and which will (1) adjust operational line items;**
13 **and (2) increase the Indirect Cost; and**

14 **WHEREAS, the FY 2017 TONHC San Simon Medical Records Program Budget Amendment**
15 **No. 1 will increase the FY 2017 TONHC San Simon Medical Records Program**
16 **Budget by \$301.80 from \$321,577.92 to \$321,879.09; and**

17 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
18 **reviewed the FY 2017 TONHC San Simon Medical Records Program Budget**
19 **Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2017 TONHC San Simon Medical Records Program Budget Amendment No. 1,**
22 **which includes a \$301.80 increase from \$321,577.92 to \$321,879.09 based on a**
23 **decrease to the indirect cost.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
25 **O'odham Nation chairperson or any designated official is authorized to**
26 **administer and expend the FY 2017 TONHC San Simon Medical Records Program**
27 **Budget as amended, provided however, that any amendments or modifications**
28 **shall be submitted to the Tohono O'odham Legislative Council for prior**
29 **approval.**

6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
7 June 18, 1934 (48 Stat.984).


