

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care, San Simon Patient
Account Budget Amendment No. 1)**

RESOLUTION NO. 17-084

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the Exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1 (d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC"), San Simon Patient**
8 **Account was approved by Resolution No. 16-524; and**

9 **WHEREAS, the TONHC San Simon Patient Accounts Department has prepared and**
10 **submitted for review and approval its FY 2017 Budget Amendment No. 1, which is**
11 **incorporated by this reference, and which will (1) adjust operational line items,**
12 **(2) create line item 7340- Public Relations; and**

13 **WHEREAS, the FY 2017 TONHC San Simon Patient Accounts Budget Amendment No. 1 does**
14 **not affect the total base budget; and**

15 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
16 **reviewed the FY 2017 TONHC San Simon Patient Account Budget Amendment No.**
17 **1 and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2017 TONHC San Simon Patient Account Budget Amendment No. 1, which does**
20 **not affect the total base budget.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
22 **O'odham Nation Chairperson or any designated official is authorized to**
23 **administer and expend the FY 2017 TONHC San Simon Patient Account Budget as**
24 **amended, provided however, that any amendments or modifications shall be**
25 **submitted to the Tohono O'odham Legislative Council for prior approval.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
27 **day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
32 **June 18, 1934 (48 Stat.984).**
