

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care Sells Purchased
Referred Care Budget Amendment No. 1)

RESOLUTION NO. 17-085

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2017 Tohono O'odham Nation Health Care ("TONHC") Sells Purchased
8 Referred Care Budget in the amount of \$1,203,343.93 was approved by
9 Resolution No. 16-524; and

10 **WHEREAS,** the Sells Purchased Referred Care has prepared and submitted for review and
11 approval its FY 2017 Budget Amendment No. 1, which is incorporated by this
12 reference and which will (1) adjust personnel and operational line items and (2)
13 decrease Indirect cost amount; and

14 **WHEREAS,** the FY 2017 TONHC Sells Purchase Referred Care Budget Amendment No. 1 will
15 decrease the FY 2017 TONHC Sells Purchase Referred Care Budget by \$4,213.17
16 from \$1,203,343.93 to \$1,199,130.76; and

17 **WHEREAS,** the Health and Human Services and the Budget and Finance Committees have
18 reviewed the FY 2017 TONHC Sells Purchased Referred Care Budget Amendment
19 No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2017 TONHC Sells Purchased Referred Care Budget Amendment No. 1, which
22 includes a \$4,213.17 decrease from \$1,203,343.93 to \$1,199,130.76 based on a
23 decrease to Indirect cost.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
25 O'odham Nation chairperson or any designated official is authorized to
26 administer and expend the FY 2017 TONHC Sells Purchased Referred Care
27 Budget as amended, provided however, that any amendments or modifications
28 shall be submitted to the Tohono O'odham Legislative Council for prior
29 approval.






