

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Tohono O'odham Nation Health Care Sells General Medical  
and Surgical Budget Amendment No. 1)**

**RESOLUTION NO. 17-086**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC") Sells General**  
8 **Medical and Surgical Budget in the amount of \$15,614,804.86 was approved by**  
9 **Resolution No. 16-524; and**

10 **WHEREAS, the TONHC Sells General Medical and Surgical Department prepared and has**  
11 **submitted for review and approval its FY 2017 Budget Amendment No. 1, which is**  
12 **incorporated by this reference, and which (1) adjusts operational and personnel**  
13 **line items (2) decrease Indirect Cost; and**

14 **WHEREAS, the FY 2017 TONHC Sells General Medical and Surgical Budget Amendment No. 1**  
15 **will decrease the FY 2017 TONHC Sells General Medical and Surgical Budget by**  
16 **\$79,443.67 from \$15,614,804.86 to \$15,535,361.19; and**

17 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**  
18 **reviewed the FY 2017 TONHC Sells General Medical and Surgical Budget**  
19 **Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2017 TONHC Sells General Medical and Surgical Budget Amendment No. 1,**  
22 **which decreases the FY 2017 TONHC Sells General Medical and Surgical Budget**  
23 **by \$79,443.67 from \$15,614,804.86 to \$15,535,361.19 based on a decrease to**  
24 **Indirect Cost.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
26 **O'odham Nation chairperson or any designated official is authorized to**  
27 **administer and expend the FY 2017 TONHC Sells General Medical and Surgical**  
28 **Budget as amended, provided however, that any amendments or modifications**
