

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care Sells Safety Program Budget
Amendment No. 1)**

RESOLUTION NO. 17-087

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC") Sells Safety Program**
8 **Budget in the amount of \$279,945.27 was approved by Resolution No. 16-524; and**

9 **WHEREAS, the Sells Safety Program has prepared and submitted for review and approval its**
10 **FY 2017 Budget Amendment No. 1, which is incorporated by this reference and**
11 **which will (1) adjust operational line items, (2) Create Line Item 7210 - Dues and**
12 **Subscriptions, (3) increase Indirect Cost; and**

13 **WHEREAS, the FY 2017 TONHC Sells Safety Program Budget Amendment No. 1 will increase**
14 **the FY 2017 TONHC Sells Safety Program Budget by \$100.60 from \$279,945.27 to**
15 **\$280,045.87; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
17 **reviewed the FY 2017 TONHC Sells Safety Program Budget Amendment No. 1 and**
18 **recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2017 TONHC Sells Safety Program Budget Amendment No. 1, which includes a**
21 **\$100.60 increase from \$279,945.27 to \$280,045.87 based on an increase to**
22 **Indirect Cost and the creating of line item 7210 - Dues and Subscriptions.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
24 **O'odham Nation chairperson or any designated official is authorized to**
25 **administer and expend the FY 2017 TONHC Sells Safety Program Budget as**
26 **amended, provided however, that any amendments or modifications shall be**
27 **submitted to the Tohono O'odham Legislative Council for prior approval.**


