

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care Sells Medical
Records Budget Amendment No. 1)

RESOLUTION NO. 17-088

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC") Sells Medical**
8 **Records Budget in the amount of \$1,400,666.43 was approved by Resolution No.**
9 **16-524; and**

10 **WHEREAS, the Sells Medical Records has prepared and submitted for review and approval**
11 **its FY 2017 Budget Amendment No. 1, which is incorporated by this reference**
12 **and which will adjust (1) personnel and operational line items; and (2) decrease**
13 **to Indirect Cost; and**

14 **WHEREAS, the FY 2017 TONHC Sells Medical Records Budget Amendment No. 1 will decrease**
15 **the FY 2017 TONHC Sells Medical Records Budget by \$6,246.01 from \$1,400,666.43**
16 **to \$1,394,420.42; and**

17 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
18 **reviewed the FY 2017 TONHC Sells Medical Records Budget Amendment No. 1**
19 **and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2017 TONHC Sells Medical Records Budget Amendment No. 1, which includes**
22 **a \$6,246.01 decrease from \$1,400,666.43 to \$1,394,420.42 and decreases to**
23 **Indirect cost.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
25 **O'odham Nation chairperson or any designated official is authorized to**
26 **administer and expend the FY 2017 TONHC Sells Medical Records Budget as**
27 **amended, provided however, that any amendments or modifications shall be**
28 **submitted to the Tohono O'odham Legislative Council for prior approval.**


