

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care Sells Pathology and
Medical Lab Budget Amendment No. 1)**

RESOLUTION NO. 17-091

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC"), Sells Pathology and**
8 **Medical Lab Budget in the amount of \$2,881,148.14 was approved by Resolution**
9 **No. 16-524; and**

10 **WHEREAS, the TONHC Sells Pathology and Medical Lab Program has prepared and**
11 **submitted for review and approval its FY 2017 Sells Pathology and Medical Lab**
12 **Budget Amendment No. 1, which is incorporated by this reference which will (1)**
13 **adjust operational, personnel and capital line items; and (2) create line item**
14 **7330 Recruiting Expense; and (3) increase Indirect Cost; and**

15 **WHEREAS, the FY 2017 TONHC Sells Pathology and Medical Lab Budget Amendment No. 1**
16 **will increase the FY 2017 TONHC Sells Pathology and Medical Lab Budget by**
17 **\$3,420.40 from \$2,881,148.14 to \$2,884,568.54; and**

18 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
19 **reviewed the FY 2017 TONHC Sells Pathology and Medical Lab Budget**
20 **Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2017 TONHC Sells Pathology and Medical Lab Budget Amendment No. 1, which**
23 **increases the FY 2017 TONHC Sells Pathology and Medical Lab Budget by**
24 **\$3,420.40 from \$2,881,148.14 to \$2,884,568.54, creates 7330 Recruiting Expense**
25 **and increase to Indirect Cost.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
27 **O'odham Nation chairperson or any designated official is authorized to**
28 **administer and expend the FY 2017 TONHC Sells Pathology and Medical Lab**
29 **Budget as amended, provided however, that any amendments or modifications**

shall be submitted to the Tohono O'odham Legislative Council for prior approval.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


