

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Tohono O'odham Nation Health Care Sells EMS Dispatch  
Budget Amendment No. 1)**

**RESOLUTION NO. 17-092**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC") Sells EMS Dispatch**  
8 **Budget in the amount of \$2,661,268.34 was approved by Resolution No. 16-524;**  
9 **and**

10 **WHEREAS, the Sells EMS Dispatch has prepared and submitted for review and approval its**  
11 **FY 2017 Budget Amendment No. 1, which is incorporated by this reference and**  
12 **which will (1) adjust personnel expenses to reflect the 2.16% COLA; and (2) adjust**  
13 **an operational line item; and**

14 **WHEREAS, the FY 2017 TONHC Sells EMS Dispatch Budget Amendment No. 1 will not**  
15 **increase the FY 2017 TONHC Sells EMS Dispatch Budget; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
17 **reviewed the FY 2017 TONHC Sells EMS Dispatch Budget Amendment No. 1 and**  
18 **recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **FY 2017 TONHC Sells EMS Dispatch Budget Amendment No. 1, which will adjust**  
21 **personnel line items to reflect 2.16% COLA.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
23 **O'odham Nation chairperson or any designated official is authorized to**  
24 **administer and expend the FY 2017 TONHC Sells EMS Dispatch Budget as**  
25 **amended, provided however, that any amendments or modifications shall be**  
26 **submitted to the Tohono O'odham Legislative Council for prior approval.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>**  
28 **day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
33 **June 18, 1934 (48 Stat.984).**
