

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care San Xavier Dental
Services Budget Amendment No. 1)**

RESOLUTION NO. 17-094

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC") San Xavier Dental**
8 **Services Budget in the amount of \$2,436,061.38 was approved by Resolution No.**
9 **16-524; and**

10 **WHEREAS, the San Xavier Dental Services has prepared and submitted for review and**
11 **approval its FY 2017 Budget Amendment No. 1, which is incorporated by this**
12 **reference which (1) adjusts personnel and operational line items; and (2) creates**
13 **line item 7355 Professional Services; and (3) decreases Indirect cost; and**

14 **WHEREAS, the FY 2017 TONHC San Xavier Dental Services Budget Amendment No. 1 will**
15 **decrease the FY 2017 TONHC San Xavier Dental Services Budget by \$13,029.17**
16 **from \$2,436,061.38 to \$2,423,032.21; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2017 TONHC San Xavier Dental Services Budget Amendment No.**
19 **1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2017 TONHC San Xavier Dental Services Budget Amendment No. 1 which will**
22 **decrease the FY2017 TONHC San Xavier Dental Services by \$13,029.17 from**
23 **\$2,436,061.38 to \$2,423,032.21, creates 7355 Professional Services line item and**
24 **decrease Indirect Cost.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
26 **O'odham Nation chairperson or any designated official is authorized to**
27 **administer and expend the FY 2017 TONHC San Xavier Dental Services Budget as**
28 **amended, provided however, that any amendments or modifications shall be**
29 **submitted to the Tohono O'odham Legislative Council for prior approval.**
