

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care San Xavier Medical
Records Budget Amendment No. 1)**

RESOLUTION NO. 17-095

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC") San Xavier Medical**
8 **Records Budget in the amount of \$839,346.73 was approved by Resolution No. 16-**
9 **524; and**

10 **WHEREAS, the San Xavier Medical Records Budget was prepared and submitted for review**
11 **and approval its FY 2017 Budget Amendment No. 1, which is incorporated by this**
12 **reference and which (1) adjusts personnel and operational line items; and (2)**
13 **decreases Indirect Cost; and**

14 **WHEREAS, the FY 2017 TONHC San Xavier Medical Records Budget Amendment No. 1 will**
15 **decrease the FY 2017 TONHC San Xavier Medical Records Budget by \$591.52 from**
16 **\$839,346.73 to \$838,755.21; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2017 TONHC San Xavier Medical Records Budget Amendment**
19 **No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2017 TONHC San Xavier Medical Records Budget Amendment No. 1 which**
22 **decreases the FY 2017 TONHC San Xavier Medical Records Budget by \$591.52**
23 **from \$839,346.73 to \$838,755.21 and decreases Indirect Cost.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
25 **O'odham Nation chairperson or any designated official is authorized to**
26 **administer and expend the FY 2017 TONHC San Xavier Medical Records Budget**
27 **as amended, provided however, that any amendments or modifications shall be**
28 **submitted to the Tohono O'odham Legislative Council for prior approval.**
