

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care San Xavier Outpatient
Budget Amendment No. 1)**

RESOLUTION NO. 17-096

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC"), San Xavier**
8 **Outpatient Budget in the amount of \$3,108,347.46 was approved by Resolution**
9 **No. 16-524; and**

10 **WHEREAS, the TONHC has prepared and submitted for review and approval its FY 2017 San**
11 **Xavier Outpatient Budget Amendment No. 1, which is incorporated by this**
12 **reference which will (1) adjusts operational, personnel and capital line items;**
13 **and (2) creates 7010 Program Supplies; and (3) decreases Indirect Cost; and**

14 **WHEREAS, the FY 2017 TONHC San Xavier Outpatient Budget Amendment No. 1 will**
15 **decrease the FY 2017 TONHC San Xavier Outpatient Budget by \$1,408.46 from**
16 **\$3,108,347.46 to \$3,106,939.00; and**

17 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
18 **reviewed the FY 2017 TONHC San Xavier Outpatient Budget Amendment No. 1**
19 **and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2017 TONHC San Xavier Outpatient Budget Amendment No. 1, which includes**
22 **a \$1,408.46 decrease from \$3,108,347.46 to \$3,106,939.00, creates 7010 Program**
23 **Supplies and decreases Indirect Cost.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
25 **O'odham Nation chairperson or any designated official is authorized to**
26 **administer and expend the FY 2017 TONHC San Xavier Outpatient Budget as**
27 **amended, provided however, that any amendments or modifications shall be**
28 **submitted to the Tohono O'odham Legislative Council for prior approval.**
