

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care San Xavier Patient
Accounts Budget Amendment No. 1)

RESOLUTION NO. 17-097

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2017 Tohono O'odham Nation Health Care ("TONHC") San Xavier Patient
8 Accounts Budget in the amount of \$2,557,426.84 was approved by Resolution No.
9 16-524; and

10 **WHEREAS,** the San Xavier Patient Accounts has prepared and submitted for review and
11 approval its FY 2017 Budget Amendment No. 1, which is incorporated by this
12 reference which will (1) adjusts personnel and operational line items; and (2)
13 decreases Indirect Cost; and

14 **WHEREAS,** the FY 2017 TONHC San Xavier Patient Accounts Budget Amendment No. 1 will
15 decrease the FY 2017 TONHC San Xavier Patient Accounts Budget by \$5,017.00
16 from \$2,557,426.84 to \$2,552,409.84; and

17 **WHEREAS,** the Health and Human Services and the Budget and Finance Committees have
18 reviewed the FY 2017 TONHC San Xavier Patient Accounts Budget Amendment
19 No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2017 TONHC San Xavier Patient Accounts Budget Amendment No. 1, which
22 includes a \$5,017.00 decrease from \$2,557,426.84 to \$2,552,409.84 and decreases
23 Indirect Cost.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
25 O'odham Nation chairperson or any designated official is authorized to
26 administer and expend the FY 2017 TONHC San Xavier Patient Accounts Budget
27 as amended, provided however, that any amendments or modifications shall be
28 submitted to the Tohono O'odham Legislative Council for prior approval.
