

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Schuk Toak District Budget Amendment No. 1)**

RESOLUTION NO. 17-101

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3
4 No district council shall expend district funds except pursuant to budgets
5 authorized under resolutions of the district council and approved by the Tohono
6 O'odham Council. The management of these funds shall be only by a treasurer
7 or other authorized officer of the district council who has furnished a surety
8 bond satisfactory to the treasurer of the Tohono O'odham Nation, and all
9 expenditures of these funds shall be by checks signed by such treasurer or other
10 authorized officer and the chairman or vice chairman of the district council.

13 **WHEREAS,** the FY 2017 Schuk Toak District Budget is in the amount of \$5,046,122.47
14 approved by Tohono O'odham Legislative Council Resolution No. 16-468
15 "Approving FY 2017 Schuk Toak District Budgets"; and

16 **WHEREAS,** the Nation's Budget Instructions for FY 2017 has changed line item 7675
17 Scholarship & Tuition to new term *Education Assistance* and was required by
18 Budget and Finance Committee to amend district budgets to reflect the change,
19 the Schuk Toak District does use the Nation's Budget Instructions per district
20 policy; and

21 **WHEREAS,** the Budget and Finance Committee has reviewed and recommends approval of
22 the FY 2017 Schuk Toak District Budget Amendment No. 1 for seven of the
23 community budgets.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 FY 2017 Schuk Toak District Budget Amendment No. 1 which will amend budgets
26 for:

28 San Pedro Community

29 Queens Well Community

BE IT FURTHER RESOLVED that these amendments will reflect the name change of Line Item 7675 - *Education Assistance* and Fresnal Community is amending language to Line Item 7615 Donation/Contribution and this amendment does not alter the overall FY 2017 Schuk Toak District budget of \$5,046,122.47.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2017 Schuk Toak District Budget Amendment No. 1 shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; ~~0~~ AGAINST; ~~0~~ NOT VOTING; and [09] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).




