

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Hewel Ni'ok's KOHN Corporation for Public Broadcasting
Community Service Grant Budget Amendment No. 1)**

RESOLUTION NO. 17-102

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the FY 2017 Hewel Ni'ok's KOHN Corporation for Public Broadcasting Community**
8 **Service Grant Budget in the amount of \$272,585.47 was approved by Resolution**
9 **No. 16-359; and**

10 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2017**
11 **Budget Amendment No. 1, which is incorporated by this reference and which will**
12 **adjust operational and personnel line items; and**

13 **WHEREAS, the FY 2017 Hewel Ni'ok's KOHN Corporation for Public Broadcasting Community**
14 **Service Grant Budget Amendment No. 1 will decrease the Hewel Ni'ok's FY 2017**
15 **KOHN Corporation for Public Broadcasting Community Service Grant Budget by**
16 **\$77,478.01 from \$272,585.47 to 195,107.46; and**

17 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees have reviewed**
18 **the FY 2017 Hewel Ni'ok's KOHN Corporation for Public Broadcasting Community**
19 **Service Grant Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2017 Hewel Ni'ok's KOHN Corporation for Public Broadcasting Community**
22 **Service Grant Budget Amendment No. 1 effective October 1, 2016, which includes**
23 **a \$77,478.01 decrease from \$272,585.47 to \$195,107.46.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2017 Hewel Ni'ok's KOHN Corporation for Public Broadcasting**
27 **Community Service Grant Budget as amended, provided however, that any**
28 **amendments or modifications shall be submitted for prior approval by the**
29 **Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
31 **day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
