Preparedness and Response)**

**RESOLUTION NO. 17-113**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**  
2 **with the power "to consult, negotiate and conclude agreements and contracts on**  
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**  
4 **and other Indian tribes or their departments, agencies, or political**  
5 **subdivisions, or with private persons or organizations on all matters within the**  
6 **authority of the Tohono O'odham Council." (Constitution, Article VI, Section**  
7 **1(f)); and**

8 **WHEREAS, the Nation approved Intergovernmental Agreement ADHS16-102341 with the**  
9 **Arizona Department of Health Services by Resolution No. 15-400; and**


10 **WHEREAS, the Arizona Department of Health Services has submitted the Amendment No. 1**  
11 **to the Intergovernmental Agreement, which updates the Scope of Work and**  
12 **Price Sheet; and**

13 **WHEREAS, the Health and Human Services Committee has reviewed the amendment and**  
14 **recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
16 **Amendment No. 1 to Intergovernmental Agreement ADHS16-102341 and**  
17 **authorizes the Tohono O'odham Chairperson to execute it in substantially the**  
18 **form attached.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>**  
20 **day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 2,908.15 FOR;**  
21 **113.25 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the**  
22 **Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted**  
23 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
24 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
25 **Act of June 18, 1934 (48 Stat.984).**
