

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services Cenpatico Tas
Tonlik Ki Budget)**

RESOLUTION NO. 17-118

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[A]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the Department of Health and Human Services Tas Tonlik Ki Program has**
8 **prepared and submitted for review and approval its FY 2017 Cenpatico Tas**
9 **Tonlik Ki Budget, which is incorporated by this reference, in the amount of**
10 **\$5,619.31 to be funded from the Cenpatico Reinvestment Grant; and**

11 **WHEREAS, the Department of Health and Human Services Tas Tonlik Ki Program is**
12 **requesting a waiver of the IDC rate charge as this is a revenue account; and**

13 **WHEREAS, the Health and Human Service and Budget and Finance Committees have**
14 **reviewed the FY 2017 Department of Health and Human Services Cenpatico Tas**
15 **Tonlik Ki Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2017 Department of Health and Human Services Cenpatico Tas Tonlik Ki**
18 **Budget in the amount of \$5,619.31 which shall be funded by Cenpatico**
19 **Reinvestment Grant and waives the IDC rate charge.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
21 **O'odham Nation chairperson or any designated official is authorized to**
22 **administer and expend the FY 2017 Department of Health and Human Services**
23 **Cenpatico Tas Tonlik Ki Budget, provided that any amendments or**
24 **modifications shall be submitted for prior approval by the Tohono O'odham**
25 **Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
27 **day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
32 **June 18, 1934 (48 Stat.984).**
