

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Accepting the Substance Abuse Mental Health Services Administration Native  
Connections Grant and Approving the FY 2017 Tohono O'odham Department  
of Health and Human Services, Substance Abuse Mental Health Services  
Administration Native Connections Grant Budget)**

**RESOLUTION NO. 17-119**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to  
3 appropriate these funds for the benefit of the nation and its members" provided  
4 that "[A]ll expenditures of these funds shall be pursuant to appropriations or  
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono  
6 O'odham Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the Tohono O'odham Nation received an award notice in the amount of  
8 \$200,000.00 for the first year of the five-year funding cycle for the period of  
9 September 30, 2016 through September 29, 2017, from the Substance Abuse  
10 Mental Health Services Administration (SAMHSA) Native Connections Grant; and

11 **WHEREAS,** the Division of Behavioral Health has prepared and submitted for review and  
12 approval its FY 2017 budget in the amount of \$200,000.00 which is incorporated  
13 by this reference; and

14 **WHEREAS,** the Health and Human Services and the Budget and Finance Committees have  
15 reviewed the FY 2017 Tohono O'odham Department of Health and Human  
16 Services SAMHSA Wecij O'odham Namke (Young People's Connections) Budget  
17 and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council that it  
19 accepts and approves the FY 2017 Tohono O'odham Department of Health and  
20 Human Services (SAMHSA) Native Connection's Grant Wecij O'odham Namke  
21 Budget effective September 30, 2016 in the amount of \$200,000.00 to be funded  
22 via reimbursement from the SAMHSA Native Connection's Grant for the  
23 continuation of this grant.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono  
25 O'odham chairperson or any designated official is authorized to administer,  
26 including following any cash management requirements from the funding  
27 agency, and expend the FY 2017 Tohono O'odham Department of Health and  
28 Human Services SAMHSA Wecij O'odham Namke (Young People's Connections)

Budget, provided however that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2)and(3)and1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


