

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services, Division of Senior Services,
Title VI-C Caregiver Support; Title VI-A Grants for Native Americans; and Title VI
Nutrition Services Incentive Program Budget Amendments No. 1)

RESOLUTION NO. 17-120

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(3)); and**

7 **WHEREAS, the FY 2017 Senior Services Division Title VI-C Caregiver Support Budget in the**
8 **amount of \$57,120.00; the Title VI-A Grants for Native Americans Budget in the**
9 **amount of \$184,510.00; and the Title VI Nutrition Services Incentive Budget in**
10 **the amount of \$2,432.00 were approved by Resolution No. 16-232; and**

11 **WHEREAS, the Department of Health and Human Services ("DHHS"), Division of Senior**
12 **Services has prepared and submitted for review and approval its FY 2017 Title VI**
13 **Budget Amendments No. 1, which are incorporated herein by this reference and**
14 **which will utilize carryover funds to adjust operational and personnel line**
15 **items; and**

16 **WHEREAS, the FY 2017 Title VI-C Caregiver Support Budget Amendment No. 1 will increase**
17 **the FY 2017 Title VI-C Caregiver Support Budget by \$8,243.53 from \$57,120.00 to**
18 **\$65,363.53; and**

19 **WHEREAS, the FY 2017 Title VI-A Grants for Native Americans Budget Amendment No. 1 will**
20 **increase the FY 2017 Title VI-A Grants for Native Americans Budget by \$79,493.52**
21 **from \$184,510.00 to \$264,003.52; and**

22 **WHEREAS, the FY 2017 Title VI Nutrition Services Incentive Program Budget Amendment**
23 **No. 1 will increase the FY 2017 Title VI Nutrition Services Incentive Budget by**
24 **\$1,394.76 from \$2,432.00 to \$3,826.76; and**

25 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
26 **reviewed the FY 2017 DHHS Division of Senior Services Title VI Budget**
27 **Amendments No. 1 and recommend their approval.**

1 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
2 **FY 2017 DHHS Division of Senior Services Title VI-C Caregiver Support Budget**
3 **Amendment No. 1, which includes a \$8,243.53 increase from \$57,120.00 to**
4 **\$65,363.53; Title VI-A Grants for Native Americans Budget Amendment No. 1,**
5 **which includes a \$79,493.52 increase from \$184,510.00 to \$264,003.52; and Title**
6 **VI Nutrition Services Incentive Program Budget Amendment No. 1, which**
7 **includes a \$1,394.76 increase from \$2,432.00 to \$3,826.76 that shall be funded via**
8 **reimbursement of carryover funds from the U.S. Department of Health and**
9 **Human Services for the continuation of this grant**

10 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
11 **O'odham Nation chairperson or any designated official is authorized to**
12 **administer including any cash management requirements from the funding**
13 **agency and expend the FY 2017 DHHS Division of Senior Services Title VI-C**
14 **Caregiver Support; Title VI-A Grants for Native Americans; and Title VI Nutrition**
15 **Services Incentive Program Budgets as amended, provided however, that any**
16 **amendments or modifications shall be submitted to the Tohono O'odham**
17 **Legislative Council for prior approval.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
19 **day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 2,764.65 FOR;**
20 **256.75 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the**
21 **Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation,**
22 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
23 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
24 **16 of the Act of June 18, 1934 (48 Stat.984).**
