

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Department of Public Safety, Sex Offender Registration and  
Notification Act Program Budget)**

**RESOLUTION NO. 17-121**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the U.S. Department of Justice awarded the Tohono O'odham Nation federal**  
8 **grant funding to support, maintain, and refine jurisdiction-wide Sex Offender**  
9 **Registration and Notification Act ("SORNA") programs and functions by**  
10 **improving victim notification services and in increasing service capacity by**  
11 **hiring a SORNA specialist; and**

12 **WHEREAS, the Tohono O'odham Legislative Council accepted the grant funding—with an**  
13 **effective date of October 1, 2015 through September 30, 2017—by Resolution No.**  
14 **15-482; and**

15 **WHEREAS, the Department of Public Service ("DPS") has prepared and submitted for review**  
16 **and approval its FY 2017 SORNA Program Budget, which is incorporated by this**  
17 **reference, in the amount of \$202,432.02 to be funded via reimbursement from**  
18 **the U.S. Department of Justice; and**

19 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees have reviewed the**  
20 **FY 2017 DPS SORNA Program Budget and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2017 DPS SORNA Program Budget, effective October 1, 2016, in the amount of**  
23 **\$202,432.02 that shall be funded via reimbursement from the U.S. Department of**  
24 **Justice.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
26 **O'odham Nation chairperson or any designated official is authorized to**  
27 **administer, including following any cash management requirements from the**  
28 **funding agency, and expend the FY 2017 DPS SORNA Program Budget as**

amended, provided however, that any amendments or modifications shall be submitted to the Tohono O'odham Legislative Council for prior approval.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> day of MARCH, 2017 at a meeting at which a quorum was present with a vote of 2,764.65 FOR; 256.75 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
