

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Membership Services Enrollment Program
Bureau of Indian Affairs (BIA) Budget)

RESOLUTION NO. 17-129

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Membership Services Enrollment Program received from the**
8 **Bureau of Indian Affairs one-time 638 funding allocation by amendment/**
9 **modification number 0081 to the P.L. 93-638 Master Contract in the amount of**
10 **\$48,880.08; and**

11 **WHEREAS, the Department of Membership Services Enrollment Program has prepared and**
12 **submitted for review and approval its FY 2017 BIA Budget, which is incorporated**
13 **by this reference, in the amount of \$48,880.08, which shall be funded by the**
14 **Bureau of Indian Affairs one-time 638 funding allocation; and**

15 **WHEREAS, the Rules and the Budget and Finance Committees of the Tohono O'odham**
16 **Legislative Council have reviewed the FY 2017 Department of Membership**
17 **Services Enrollment Program BIA Budget and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**
19 **approves the FY 2017 Department of Membership Services Enrollment Program**
20 **BIA Budget in the amount of \$48,880.08, which shall be funded by the Bureau of**
21 **Indian Affairs one-time 638 funding allocation.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2017 Department of Membership Services Enrollment Program BIA**
25 **Budget, provided that any amendments or modifications shall be submitted for**
26 **approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD**
28 **day of APRIL, 2017 at a meeting at which a quorum was present with a vote of 3,021,4 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
