

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Fiscal Year 2017 Sells Community Budget Amendment No. 1 and
Sells District Administration Budget Amendment No. 2)**

RESOLUTION NO. 17-131

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation, "No district council shall expend district funds except pursuant to
3 budgets authorized under resolutions of the district council and approved by the
4 Tohono O'odham Council. The management of these funds shall be only by a
5 treasurer or other authorized officer of the district council who has furnished a
6 surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and all
7 expenditures of these funds shall be by checks signed by such treasurer or other
8 authorized officer and the chairman or vice chairman of the district council"; and

9 **WHEREAS,** Tohono O'odham Legislative Council did pass Resolution No. 16-470 approving
10 the budgets submitted for Fiscal Year 2017 for Sells District Administration and
11 its communities; and

12 **WHEREAS,** Sells Community has nearly depleted the original budget approved and have
13 identified the need to request for further funding to continue to meet the needs
14 of their community members; and

15 **WHEREAS,** Sells Community Budget Amendment No. 1 will increase all line items for a total
16 amount of \$105,000.00 causing Sells District Budget Amendment No. 2 to decrease
17 line item 7620 Miscellaneous Assistance for the same amount; and

18 **WHEREAS,** Sells Community and Sells District Administration have both prepared and
19 acquired approval of the attached Budget Amendment No. 1 and Budget
20 Amendment No. 2 and their justifications with Sells District Council Resolution
21 No. SD-109-16; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed Fiscal Year 2017 Sells
23 Community Budget Amendment No. 1 and Sells District Administration Budget
24 Amendment No. 2 and recommends their approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
26 Fiscal Year 2017 Sells Community Budget Amendment No. 1 and Sells District
27 Administration Budget Amendment No. 2 moving around a total amount of
28 \$105,000.00, as attached.

29 **BE IT FURTHER RESOLVED** that this amendment will increase Sells Community budget from
30 \$85,000 to a new total \$190,000 and decrease Sells District Administration Budget
31 from \$1,838,486.42 to a new total of \$1,733,486.42 which does not affect the

1 approved overall Sells District Fiscal Year 2017 budgeted amount of
2 \$2,178,486.42.

3 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the
4 Sells District Chairperson and any designated District Official to expend and
5 administer the budget as attached, provided that any modifications or
6 amendments affecting the funds or funding levels of the budget shall be
7 submitted for prior approval by the Tohono O'odham Legislative Council.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD
9 day of APRIL, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-
10 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
11 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
12 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
13 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
14 18, 1934 (48 Stat.984).


