

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services Behavioral
Health Domestic Violence Program Grant Budget)

RESOLUTION NO. 17-132

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the Department of Health and Human Services ("DHHS") has prepared and**
8 **submitted for review and approval its FY 2017 Behavioral Health Domestic**
9 **Violence Program Grant Budget, which is incorporated by this reference, in the**
10 **amount of \$49,750.00 to be funded via reimbursement by the Indian Health**
11 **Service; and**

12 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
13 **reviewed the FY 2017 DHHS Behavioral Health Domestic Violence Program Grant**
14 **Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2017 DHHS Behavioral Health Domestic Violence Program Grant Budget,**
17 **effective October 1, 2016, in the amount of \$49,750.00 that shall be funded via**
18 **reimbursement by the Indian Health Service for the continuation of this grant.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
20 **Nation chairperson or any designated official is authorized to administer,**
21 **including following any cash management requirements from the funding**
22 **agency, and expend the FY 2017 DHHS Behavioral Health Domestic Violence**
23 **Program Grant Budget, provided however, that any amendments or**
24 **modifications shall be submitted to the Tohono O'odham Legislative Council for**
25 **prior approval.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD day**
27 **of APRIL, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
