

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Legislative Branch Budget Amendment No. 2)

RESOLUTION NO. 17-133

1 **WHEREAS, the Legislative Council is authorized “to manage any funds within the exclusive**
2 **control of the Tohono O’odham Nation . . . and to appropriate these funds for the**
3 **benefit of the nation and its members” provided that “[a]ll expenditures of these**
4 **funds shall be pursuant to appropriations or budgets” authorized by resolution**
5 **or ordinance (Constitution of the Tohono O’odham Nation, Article VI, Section 1(d)**
6 **(2)); and**

7 **WHEREAS, the Legislative Branch FY 2017 budget was approved by Resolution No. 16-324 and**
8 **amended by Resolution No. 16-573 for amendment No. 1; and**

9 **WHEREAS, the Legislative Branch administration has prepared and submitted for review**
10 **and approval of its FY 2017 Budget Amendment No. 2, which is incorporated by**
11 **this reference and which will increase and decrease personnel and operational**
12 **line items; and**

13 **WHEREAS, FY 2017 Legislative Branch Budget Amendment No. 2 will not increase the amount**
14 **of funds originally appropriated to Legislative Branch FY 2017 Budget; and**

15 **WHEREAS, FY 2017 Legislative Branch Budget Amendment No. 2 has been reviewed and**
16 **recommends approval by the Budget and Finance Committee.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council approves the**
18 **FY 2017 Legislative Branch Budget Amendment No. 2 effective on the date of this**
19 **resolution, as attached hereto.**


20 **BE IT FINALLY RESOLVED by the Tohono O’odham Legislative Council Chairperson and Vice-**
21 **Chairperson are authorized to administer the FY 2017 Legislative Branch Budget**
22 **as amended, provided however, that any amendments affecting these funds or**
23 **funding levels budgeted shall be submitted for prior approval by the Tohono**
24 **O’odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 03RD day**
26 **of APRIL, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O’odham Nation, adopted by**
29 **the Tohono O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**


