

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting April 18-19, 2017 Special Session to Address Appointments to the Community  
Development Financial Institution Board of Directors, Economic Development Authority  
Board of Directors, and Tohono O'odham Utility Authority Management Board)**

**LEGISLATIVE ORDER NO. 17-134**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**  
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**  
3 **committees, boards and special committees." (Constitution of the Tohono**  
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council**  
6 **with the authority to "by majority vote, call for a special session" (Legislative**  
7 **Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**


8 **WHEREAS, the Commerce Committee has requested a special session on April 18-19, 2017 to**  
9 **address the appointments of candidates for the following:**

- 10 1. **Community Development Financial Institution Board of Directors**
- 11 2. **Economic Development Authority Board of Directors**
- 12 3. **Tohono O'odham Utility Authority Management Board**

13 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**  
14 **special session on April 18-19, 2017 to address the appointments of candidates to**  
15 **the Community Development Financial Institution Board of Directors, Economic**  
16 **Development Authority Board of Directors, and Tohono O'odham Utility**  
17 **Authority Management Board.**

18 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup> day of**  
19 **APRIL 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; 90.30**  
20 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
21 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
24 **18, 1934 (48 Stat.984).**
