

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services Senior Services
Division Long Term Care (LTC) Ombudsman and Title III Caregiver Health Promotion
Report (HPR) Chronic Disease Self-Management Program (CDSMP) Budgets)**

RESOLUTION NO. 17-135

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services Senior Services Division has
8 prepared and submitted for review its FY 2017 LTC Ombudsman Budget in the
9 amount of \$10,000.00 and its FY 2017 Title III Caregiver HPR CDSMP Budget in
10 the amount of \$1,000.00, which are incorporated by this reference, each with a
11 project period beginning July 1, 2016 to June 30, 2017 and which shall both be
12 funded by Title III of the Older Americans Act through the Inter-Tribal Council of
13 Arizona; and

14 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
15 reviewed the Health and Human Services Senior Services Division FY 2017 LTC
16 Ombudsman Budget and the FY 2017 Title III Caregiver HPR CDSMP Budget and
17 recommend their approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2017 Department of Health and Human Services Senior Services Division LTC
20 Ombudsman Budget in the amount of \$10,000.00 and the Title III Caregiver HPR
21 CDSMP Budget in the amount of \$1,000.00 with a project period beginning July 1,
22 2016 to June 30, 2017 which shall be funded by Title III of the Older Americans
23 Act through the Inter-Tribal Council of Arizona and authorizes the utilization of
24 the Nation's resources pending reimbursement from the Grantor.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
26 O'odham Nation chairperson or any designated official is authorized to
27 administer and expend the FY 2017 Department of Health and Human Services
28 Senior Services Division LTC Ombudsman Budget and the Title III Caregiver HPR

HPR CDSMP Budget, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.
