

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Judicial Branch Budget Amendment No. 3)**

**RESOLUTION NO. 17-137**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2017 Judicial Branch**  
8 **Budget by Resolution No. 16-325 and further amended the budget by resolution**  
9 **16-457 for a total budget in the amount of 6,760,442.69; and**

10 **WHEREAS, the Judicial Branch has prepared the attached FY 2017 Budget Amendment No. 3**  
11 **to (1) create the following new Operational line items: 6530 Transportation,**  
12 **6700 Awards-Client, and 6725 Awards - Employees; and (2) increases and**  
13 **decreases operational line items which will not increase the total budget**  
14 **amount; and**

15 **WHEREAS, the Judiciary and Budget and Finance Committees of the Legislative Council**  
16 **have reviewed this budget and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
18 **approves the FY 2017 Judicial Branch Budget Amendment No. 3 as attached.**

19 **BE IT FURTHER RESOLVED that this amendment will create new Operational line items: 6530**  
20 **Transportation, 6700 Awards-Client, and 6725 Awards - Employees which will**  
21 **not increase the total budget amount.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
23 **Chief Judge and any designated official to expend and administer the budget as**  
24 **attached, provided that any modifications or amendments affecting the funds or**  
25 **funding level shall be submitted for prior approval by the Tohono O'odham**  
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>**  
28 **day of APRIL, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
33 **June 18, 1934 (48 Stat.984).**
