

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Gu Achi District's Fiscal Year 2017 Budget Amendment #1 for**  
**the Gu Achi District Administration)**

**RESOLUTION NO. 17-140**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized *"to manage any funds*  
2 *within the exclusive control of the Tohono O'odham Nation...and to appropriate*  
3 *these funds for the benefit of the nation and its members" provided that "(a)All*  
4 *expenditures of these funds shall be pursuant to appropriations or budgets"*  
5 *authorized by resolution ordinance (Constitution of the Tohono O'odham Nation,*  
6 *Article VI, Section 1(d)(3)); and*

7 **WHEREAS,** the Gu Achi District Council approved a budget amendment for the Gu Achi  
8 District Administration *(Resolution #0317-210); and*

9 **WHEREAS,** Gu Achi District's Fiscal Year 2017 Budget Amendment #1 was approved by Gu  
10 Achi District Administration *(Resolution #0317-210), which is incorporated by*  
11 *this reference and which incorporates additional language in the budget*  
12 *justification to include Youth Council Representatives and Alternates to receive*  
13 *compensation to attend District Council Meetings; and*

14 **WHEREAS,** the Tohono O'odham Legislative Council's Budget and Finance Committee did  
15 review the attached budget amendment and recommend its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council does hereby  
17 approve the Gu Achi District's Fiscal Year 2017 Budget Amendment #1 for the Gu  
18 Achi District Administration as listed.

19 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the  
20 District Chairperson and any designated official to expend and administer the  
21 Budget as attached, provided that any modifications/amendments affecting the  
22 funds or funding level is submitted for further prior approval by the Tohono  
23 O'odham Legislative Council.

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> day**  
25 **of APRIL, 2017 at a meeting at which a quorum was present with a vote of 2,789.8 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and 231.6 [03] ABSENT, pursuant to the powers vested in the Council**  
27 **by Article VI, Section 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat.984).**
