

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Health and Human Services Healthy O'odham
Promotion Program Budget)

RESOLUTION NO. 17-144

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2018 Healthy O'odham Promotion Program Budget,
9 which is incorporated by this reference, in the amount of \$2,241,130.00 to be
10 funded from the Special Diabetes Program for Indians which begins January 1,
11 2017 through December 31, 2017; and

12 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
13 reviewed the FY 2018 Department of Health and Human Services Healthy
14 O'odham Promotion Program Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
16 FY 2018 Department of Health and Human Services Healthy O'odham Promotion
17 Program Budget effective January 1, 2017 through December 31, 2017 in the
18 amount of \$2,241,130.00 to be funded via reimbursement from Special Diabetes
19 Program for Indians for the continuation of this grant.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
21 Nation chairperson or any designated official is authorized to administer and
22 expend, including following any cash management requirements from the
23 funding agency the FY 2018 Department of Health and Human Services Healthy
24 O'odham Promotion Program Budget, provided that any amendments or
25 modifications shall be submitted for prior approval by the Tohono O'odham
26 Legislative Council.

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH day**
28 **of APRIL, 2017 at a meeting at which a quorum was present with a vote of 2,695.3 FOR; 326.1**
29 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
