

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Professional Services Agreement Between the Tohono O'odham Nation and Tucson Unified School District – Infant and Early Learning Centers – Brichta Center)

RESOLUTION NO. 17-146

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power “to consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes or their departments, agencies, or political**
5 **subdivisions, or with private persons or organizations on all matters within the**
6 **authority of the Tohono O'odham Council.” (Constitution, Article VI, Section**
7 **1(f)); and**

8 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**
9 **affordability, and quality of child care for members of the Nation; and**

10 **WHEREAS, the Tohono O'odham Nation’s Child Care Program wishes to enter into a**
11 **Professional Services Agreement with Tucson Unified School District – Infant**
12 **and Early Learning Centers – Brichta Center to provide child care services for**
13 **the Nation’s children who are eligible to receive child care services; and**

14 **WHEREAS, the Professional Services Agreement has been reviewed by the Human**
15 **Resources Development Committee which recommends its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **Professional Services Agreement Between the Tohono O'odham Nation and**
18 **Tucson Unified School District – Infant and Early Learning Centers-Brichta**
19 **Center substantially in the form attached and authorizes the Chairman to**
20 **execnte it.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
22 **day of APRIL, 2017 at a meeting at which a quorum was present with a vote of 3,021,4 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
24 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
27 **June 18, 1934 (48 Stat.984).**
