

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District Fiscal Year 2017 Tower User Fees
(4th Quarter - 2016) Budget in the amount of \$30,873.37)

RESOLUTION NO. 17-152

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized to appropriate "funds for**
2 **the benefit of the nation and its members," including the Nation's districts,**
3 **provided that "[n]o district council shall expend district funds except pursuant to**
4 **budgets authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council." (Constitution of the Tohono O'odham Nation, Article**
6 **VI, Section 1(d)(2), Article IX, Section 7); and**

7 **WHEREAS, the Tohono O'odham Legislative Council approved a Management Agreement**
8 **between the Tohono O'odham Nation, Gu Achi District and the Tohono O'odham**
9 **Utility Authority (TOUA) for Jewek Mountain (Resolution #08-586) which allowed**
10 **the Nation and Gu Achi District to obtain a stream of revenue from TOUA's leasing**
11 **space on the transmission tower and the associated equipment building; and**

12 **WHEREAS, the Management Agreement was revised and approved by the Legislative Council**
13 **(Resolution #14-412) superseding Resolution #08-586; and**

14 **WHEREAS, the Gu Achi District Council approved Resolution #0217-206 for a budget in the**
15 **amount of \$30,873.37 from the revenue of the tower user fees, which is**
16 **incorporated by this reference; and**

17 **WHEREAS, the Budget and Finance Committee did review the Fiscal Year 2017 Tower User**
18 **Fees budget and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
20 **approve the Gu Achi District's Fiscal Year 2017 Tower User Fees (4th Quarter - 2016)**
21 **Budget in the amount of \$30,873.37 as attached hereto.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **District Chairperson and any designated official to expend and administer the**
24 **Budget as attached, provided that any modifications/amendments affecting the**
25 **funds or funding level is submitted for prior approval by the Tohono O'odham**
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day**
28 **of APRIL, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
30 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
