(Setting April 27, 2017 Special Session to Review and Consider a Census Challenge  
Proposal and Review of TOKA's Indian Community Development Block Grant Plan)**

**DEFEATED  
LEGISLATIVE ORDER NO. 17-161**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**  
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**  
3 **committees, boards and special committees." (Constitution of the Tohono**  
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council**  
6 **with the authority to "by majority vote, call for a special session" (Legislative**  
7 **Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**

8 **WHEREAS, the Housing Committee has requested a special session on April 27, 2017 Special**  
9 **Session to Review and Consider a Census Challenge Proposal and Review of**  
10 **TOKA's Indian Community Development Block Grant Plan.**

11 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**  
12 **special session on April 27, 2017 to Review and Consider a Census Challenge**  
13 **Proposal and Review of TOKA's Indian Community Development Block Grant**  
14 **Plan.**

15 **The foregoing Order was defeated by the Tohono O'odham Legislative Council on the 18<sup>TH</sup> day of**  
16 **APRIL, 2017 at a meeting at which a quorum was present with a vote of 1,207.35 FOR; 1,814.05**  
17 **AGAINST; -0- NOT VOTING and [04] ABSENT, pursuant to the powers vested in the Council by**  
18 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
19 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat.984).**
