

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Representative Chester Antone to the Department of Health and
Human Services Secretary's Tribal Advisory Committee)

RESOLUTION NO. 17-162

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the authority to "promote, protect and provide for public health, peace, morals,**
3 **education and general welfare of the Tohono O'odham Nation and its members"**
4 **and to "consult, negotiate and conclude agreements and contracts on behalf of**
5 **the Tohono O'odham Nation with Federal, State and local governments and other**
6 **Indian tribes...within the authority of the Tohono O'odham Council."**
7 **(Constitution, Article VI, Section 1(c)(2) and Section 1(f)); and**

8 **WHEREAS, the U.S. Department of Health and Human Services ("HHS") Secretary's Tribal**
9 **Advisory Committee ("STAC") was established in 2010 representing the highest**
10 **level tribal advisory committee in the HHS and is intended as a forum for**
11 **government-to-government consultation; and**

12 **WHEREAS, the STAC's primary purpose is to identify issues and priorities, seek consensus,**
13 **exchange views, share information, provide advice and recommendations, and**
14 **coordinate with HHS agencies on all matters related to improving health and**
15 **human services and ensuring tribal consultation on HHS policies affecting**
16 **American Indian and Alaska Native ("AI/AN") communities (STAC Charter); and**

17 **WHEREAS, the STAC's tribal representation is comprised of seventeen positions to be filled**
18 **by voluntary representatives: one delegate (and one alternate) from each of the**
19 **twelve Indian Health Service ("IHS") areas and one delegate (and one alternate)**
20 **for five National At-Large Tribal Member positions; and**

21 **WHEREAS, Representative Chester Antone serves as the STAC Tucson Area delegate and STAC**
22 **chairperson with a term expiring May 2017; and**

23 **WHEREAS, the Health and Human Services Committee recommends the nomination of**
24 **Representative Chester Antone to the STAC for another term.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates**
26 **Representative Chester Antone to serve as Tucson Area delegate on the**
27 **Secretary's Tribal Advisory Committee.**

28 **BE IT FINALLY RESOLVED that an appointment made pursuant to this resolution shall**
29 **immediately expire if the appointed representative no longer serves on the**
30 **Health and Human Services Committee for any reason.**
