

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Tohono O'odham Nation Health Care Sells Physical**  
**Therapy Budget Amendment No. 1)**

**RESOLUTION NO. 17-167**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Tohono O'odham Nation Health Care ("TONHC") Sells Physical**  
8 **Therapy Budget in the amount of \$922,181.16 was approved by Resolution No. 16-**  
9 **524; and**

10 **WHEREAS, the Sells Physical Therapy has prepared and submitted for review and approval**  
11 **its FY 2017 Budget Amendment No. 1, which is incorporated by this reference and**  
12 **which will (1) adjust personnel and operational line items; and (2) creating new**  
13 **line item 7015 Uniforms; and (3) increasing Indirect Cost charges; and**

14 **WHEREAS, the FY 2017 TONHC Sells Physical Therapy Budget Amendment No. 1 will increase**  
15 **the FY 2017 TONHC Sells Physical Therapy Budget by \$54,221.32 from \$922,181.16**  
16 **to \$976,402.48; and**

17 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**  
18 **reviewed the FY 2017 TONHC Sells Physical Therapy Budget Amendment No. 1 and**  
19 **recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2017 TONHC Sells Physical Therapy Budget Amendment No. 1, which includes**  
22 **a \$54,221.32 increase of Indirect Cost charges adjusting the overall budget from**  
23 **\$922,181.16 to \$976,402.48 that shall be funded by Self-Governance.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation chairperson or any designated official is authorized to administer and**  
26 **expend the FY 2017 TONHC Sells Physical Therapy Budget as amended, provided**  
27 **however, that any amendments or modifications shall be submitted to the**  
28 **Tohono O'odham Legislative Council for prior approval.**
