

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an Addition to the Master List for Eligible Adult Tohono O'odham Members**  
**for the Fourth Per Capita Distribution and Certifying and Authorizing Distribution**  
**of the Fourth Per Capita Distribution for May 2017)**

**RESOLUTION NO. 17-174**

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the**  
2 **"O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes**  
3 **per capita payments to the Nation's members provided that sufficient gaming**  
4 **revenues are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities Within the Tohono**  
6 **O'odham Nation (the "Gaming Ordinance") was subsequently amended to**  
7 **authorize per capita distribution payments in accordance with the Initiative**  
8 **(Legislative Council Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Tohono O'odham Nation Revenue**  
10 **Allocation Plan pursuant to Legislative Council Resolution No. 09-164; and**

11 **WHEREAS, on June 15, 2009, the Nation received notice from the Department of Interior**  
12 **that the Tohono O'odham Nation Revenue Allocation Plan was approved; and**

13 **WHEREAS, the Tohono O'odham Nation Department of Membership Services submitted to**  
14 **the Tohono O'odham Legislative Council the Master List for Eligible Adult**  
15 **Tohono O'odham Members for the Fourth Per Capita Distribution ("Master List")**  
16 **for review and approval; and**

17 **WHEREAS, Legislative Council approved the Master List with the initial number of 19,141**  
18 **verified adult members (Resolution Number 09-428); and**

19 **WHEREAS, the Tohono O'odham Nation Department of Membership Services has identified**  
20 **one eligible adult member who was left off the previously approved Master List;**  
21 **and**

22 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**  
23 **verification of a member and certification by the Tohono O'odham Legislative**  
24 **Council; and**

25 **WHEREAS, the Tohono O'odham Department of Membership Services has submitted a**  
26 **certification list of one verified adult member who is eligible to receive the**  
27 **fourth per capita payment.**

28 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 29 **1. Certifies and approves the addition of one eligible Tohono O'odham adult**  
30 **member to the Master List for Eligible Adult Tohono O'odham Members**  
31 **for the Fourth Per Capita Distribution, who is listed in the attached May**  
32 **2017 Certification Listing of an Adult Member for the Fourth Per Capita**  
33 **Distribution.**



2. Authorizes the transfer of \$2,000 from the Desert Diamond Savings Account at U.S. Trust to the Per Capita #4 Checking Account established at First American Credit Union.
3. Approves the distribution of \$2,000, less any applicable taxes required by federal law, to the adult member listed.
4. Authorizes the Chairperson of the Nation or a designated official to execute such other documents as may be necessary to implement this resolution.

**BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the disbursement of funds to additional eligible Tohono O'odham adult members is contingent upon verification of membership by the Tohono O'odham Department of Membership Services and certification by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup> day of MAY, 2017 at a meeting at which a quorum was present with a vote of 3,021,4 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


