

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Gu Achi District-Santa Rosa Community Budget Amendment No. 1)**

**RESOLUTION NO. 17-175**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to**  
4 **budgets authorized under resolutions of the district council and**  
5 **approved by the Tohono O'odham Council. The management of these**  
6 **funds shall be only by a treasurer or other authorized officer of the**  
7 **district council who has furnished a surety bond satisfactory to the**  
8 **treasurer of the Tohono O'odham Nation, and all expenditures of these**  
9 **funds shall be by checks signed by such treasurer or other authorized**  
10 **officer and the chairman or vice chairman of the district council.**

12 **WHEREAS, the FY 2017 Gu Achi District budget in the amount of \$2,178,486.42 was**  
13 **authorized by Tohono O'odham Legislative Council Resolution No. 16-460 and**  
14 **amended by Resolution No. 17-016; and**

15 **WHEREAS, by Gu Achi District Council by Resolution #0317-216 the Gu Achi District has**  
16 **prepared and submitted for review and approval its FY 2017 Santa Rosa**  
17 **Community Budget Amendment No. 1, which is incorporated by this reference**  
18 **and which (1) adding new line item 7400 RM Equipment; (2) increasing and**  
19 **decreasing Operational line items; and**

20 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2017 Gu Achi District-**  
21 **Santa Rosa Community Budget Amendment No. 1 and recommends its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
23 **FY 2017 Gu Achi District-Santa Rosa Community Budget Amendment No. 1 which**  
24 **will add new line item 7400 RM Equipment and increase and decrease**  
25 **Operational line items with no change to the overall budget.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2017 Gu Achi**  
27 **District-Santa Rosa Community Budget as amended shall be managed and**  
28 **expended in accordance with Article IX, Section 7 of the Constitution of the**  
29 **Tohono O'odham Nation and the Nation's laws, provided that any amendments**  
30 **or modifications shall be authorized under District Council resolution and**  
31 **submitted for prior approval by the Tohono O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup> day of MAY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
