

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY2017 Baboquivari District-Choulic Community Budget Amendment No. 1)

RESOLUTION NO. 17-177

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** Per Tohono O'odham Legislative Council Resolution No. 16-368 the Baboquivari
13 District was allocated gaming revenues in the amount of \$2,178,486.42; and

14 **WHEREAS,** Tohono O'odham Legislative Council Resolution No. 16-458 approved the FY2017
15 Baboquivari District Budgets in the amount of \$2,345,655.40; and

16 **WHEREAS,** Tohono O'odham Legislative Council approved FY2016 Apportionment of Mining
17 Royalties by Equal Distribution by Resolution No. 16-017 which allocated
18 \$115,253.30 to Baboquivari District; and

19 **WHEREAS,** by Baboquivari District Council Resolution No. 2017-B-23 Baboquivari District
20 has prepared and submitted for review and approval its FY 2017 Choulic
21 Community Budget Amendment No. 1 which is incorporated by this reference
22 and which will (1) incorporate FY 2016 Mining Royalties in the amount of
23 \$16,464.76; Gravel Sales of \$3,800.00 and FY 2013 Carry Overs in the amount
24 \$11,791.30 for a total Carry Over amount of \$32,056.06; (2) adding new language
25 to line item 7615 Donation/Contribution; and (3) increase and decrease
26 Operational line items; and

27 **WHEREAS,** the Budget and Finance Committee has reviewed FY 2017 Baboquivari District-
28 Choulic Community Budget Amendment No. 1 and recommends its approval.

29 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
30 FY 2017 Baboquivari District-Choulic Community Budget Amendment No. 1
31 which will (1) incorporate FY 2016 Mining Royalties in the amount of \$16,464.76;
32 Gravel Sales of \$3,800.00 and FY 2013 Carry Overs in the amount \$11,791.30 for a
33 total Carry Over amount of \$32,056.06; (2) adding new language to line item 7615
34 Donation/Contribution; and (3) increasing and decreasing Operational line
35 items.

1 **BE IT FURTHER RESOLVED** that amendment No. 1 will increase the FY 2017 Choulic
2 **Community Budget by \$32,056.06 increasing the community budget from**
3 **\$254,156.75 to a new total of \$286,212.81 adjusting the overall District Budget**
4 **from \$2,345,655.40 to a revised amount of \$2,377,711.46.**


5 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the
6 **District Chairperson and any designated official to expend and administer the**
7 **budget, provided that any modifications or amendments shall be submitted for**
8 **prior approval by the Tohono O'odham Legislative Council.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
10 **day of MAY, 2017 at a meeting at which a quorum was present with a vote of 2,756.4 FOR; 265.0**
11 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
12 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
13 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
14 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
15 **June 18, 1934 (48 Stat.984).**




