

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an Intergovernmental Clinical Affiliation Agreement between the State of Tennessee on behalf of The University of Tennessee Through Its Health Science Center, College of Pharmacy and the Tohono O'odham Nation)**

**RESOLUTION NO. 17-179**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**  
2 **with the power "to consult, negotiate and conclude agreements and contracts on**  
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**  
4 **and other Indian tribes or their departments, agencies, or political**  
5 **subdivisions, or with private persons or organizations on all matters within the**  
6 **authority of the Tohono O'odham Council." (Constitution, Article VI, Section**  
7 **1(f)); and**

8 **WHEREAS, the purpose of this agreement is to establish coordinated clinical educational**  
9 **programs and guidelines for the education and training of health sciences**  
10 **students classified as either externs, interns, residents and/or fellows from the**  
11 **University of Tennessee through it's Health Science Center, College of**  
12 **Pharmacy; and**

13 **WHEREAS, the University of Tennessee through it's Health Science Center, College of**  
14 **Pharmacy is currently conducting programs granting pharmacy undergraduate**  
15 **and graduate degrees, as well as residency training, and desires to obtain the**  
16 **assistance of the Tohono O'odham Nation in furthering the University's**  
17 **educational objectives; and**

18 **WHEREAS, the Tohono O'odham Nation is in need of pharmacy externs, interns, residents**  
19 **and/or fellows to provide services to its customers at the Tohono O'odham**  
20 **Healthcare Pharmacy; and**

21 **WHEREAS, the Health and Human Services Committee of the Legislative Council has**  
22 **reviewed this Agreement and recommends its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
24 **approves this Intergovernmental Clinical Affiliation Agreement between the**  
25 **State of Tennessee on behalf of The University of Tennessee through its Health**  
26 **Science Center, College of Pharmacy, and the Tohono O'odham Nation,**  
27 **substantially in the form attached hereto, and authorizes the Chairperson of the**  
28 **Nation to sign it.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup>**  
30 **day of MAY, 2017 at a meeting at which a quorum was present with a vote of 2,789.8 FOR; -0-**  
31 **AGAINST; -0- NOT VOTING; and 231.6[05] ABSENT, pursuant to the powers vested in the Council**  
32 **by Article VI Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
33 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
35 **June 18, 1934 (48 Stat.984).**




