

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving a Professional Services Agreement between RPh On The Go, Inc.,  
and the Tohono O'odham Nation)**

**RESOLUTION NO. 17-181**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**  
2 **with the power "to consult, negotiate and conclude agreements and contracts on**  
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**  
4 **and other Indian tribes or their departments, agencies, or political**  
5 **subdivisions, or with private persons or organizations on all matters within the**  
6 **authority of the Tohono O'odham Council." (Constitution, Article VI, Section**  
7 **1(f)); and**

8 **WHEREAS, Tohono O'odham Nation Health Care ("TONHC") has presented this professional**  
9 **services agreement between the Tohono O'odham Nation and RPh On The Go,**  
10 **Inc. to provide contract employees including, but not limited to, pharmacists**  
11 **and pharmacy technicians for the Tohono O'odham Nation Health Care**  
12 **Pharmacy Department; and**

13 **WHEREAS, the professional services agreement being established, in an amount not to**  
14 **exceed \$1,670,000.00, is required to adequately staff the pharmacy and to allow**  
15 **it to function at full capacity; and**

16 **WHEREAS, the Health and Human Services Committee of the Legislative Council has**  
17 **reviewed the Professional Services Agreement between RPh On The Go, Inc. and**  
18 **the Nation and recommends its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
20 **approves the Professional Services Agreement between RPh On The Go, Inc., and**  
21 **the Tohono O'odham Nation, substantially in the form attached hereto, and**  
22 **authorizes the chairperson of the Nation to execute.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup>**  
24 **day of MAY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
29 **June 18, 1934 (48 Stat.984).**
