

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services Division of Community Health Services Public Health Preparedness Zika Phase One Budget)

RESOLUTION NO. 17-182

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services Division of Community Health**
8 **Services has prepared and submitted for review and approval its FY 2017 Public**
9 **Health Preparedness Zika Phase One Budget, which is incorporated by this**
10 **reference, in the amount of \$17,500.00 to be funded by the Arizona Department**
11 **of Health Services; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2017 Department of Health and Human Services Division of**
14 **Community Health Services Public Health Preparedness Zika Phase One Budget**
15 **and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2017 Department of Health and Human Services Division of Community**
18 **Health Services Public Health Preparedness Zika Phase One Budget effective**
19 **July 1, 2016 through June 30, 2017 in the amount of \$17,500.00 which shall be**
20 **funded by the Arizona Department of Health Services.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
22 **O'odham Nation chairperson or any designated official is authorized to**
23 **administer and expend the FY 2017 Department of Health and Human Services**
24 **Division of Community Health Services Public Health Preparedness Zika Phase**
25 **One Budget, provided that any amendments or modifications shall be submitted**
26 **for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
28 **day of MAY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**




