

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Intergovernmental Agreement Amendment No. 2 to ADHS16-102341**  
**with the Arizona Department of Health Services for Public Health Emergency**  
**Preparedness and Response)**

**RESOLUTION NO. 17-183**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**  
2 **with the power "to consult, negotiate and conclude agreements and contracts on**  
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**  
4 **and other Indian tribes or their departments, agencies, or political**  
5 **subdivisions, or with private persons or organizations on all matters within the**  
6 **authority of the Tohono O'odham Council." (Constitution, Article VI, Section**  
7 **1(f)); and**

8 **WHEREAS, the Arizona Department of Health Services is responsible for distributing**  
9 **federal funds to Indian tribes in Arizona for public health preparedness and**  
10 **response; and**

11 **WHEREAS, federal funds are appropriated by the Center for Disease Control and Prevention**  
12 **to the State of Arizona for allocation to the Tohono O'odham Nation through an**  
13 **Intergovernmental Agreement with the Arizona Department of Health Services**  
14 **which was approved by Resolution No. 15-400; and**

15 **WHEREAS, the Tohono O'odham Nation Department of Health and Human Services has**  
16 **submitted the Intergovernmental Agreement Amendment No. 2 to ADHS16-**  
17 **102341 that will change the scope of work to address Zika virus prevention**  
18 **efforts in the State of Arizona; and**

19 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**  
20 **reviewed this amendment and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **Public Health Emergency Preparedness Intergovernmental Agreement**  
23 **Amendment No. 2 to ADHS16-102341 with the Arizona Department of Health**  
24 **Services and authorizes and directs the Nation's Chairman to execute the**  
25 **Intergovernmental Agreement Amendment No. 2 in substantially the form**  
26 **attached; provided that any amendment to the Intergovernmental Agreement**  
27 **be submitted to the Legislative Council for prior approval.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup>**  
29 **day of MAY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
30 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
31 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
34 **June 18, 1934 (48 Stat.984).**
