

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2017 Department of Public Safety Tohono O'odham Police
Department West Valley Resort Budget Amendment No. 2)

RESOLUTION NO. 17-186

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation...and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2017 Department of Public Safety Tohono O'odham Police Department
8 West Valley Resort Budget in the amount of \$2,183,485.16 was approved by
9 Resolution No. 16-322, and thereafter amended by Resolution No. 16-544; and

10 **WHEREAS,** the Department of Public Safety Tohono O'odham Nation Police Department has
11 prepared and submitted for review and approval its FY 2017 West Valley Resort
12 Budget Amendment No. 2, which is incorporated by this reference and which will
13 (1) adjust operational line items; (2) create new line item 7500 Major Capital (3)
14 adding new language within the justifications; and

15 **WHEREAS,** the FY 2017 Department of Public Safety Tohono O'odham Police Department
16 West Valley Resort Budget Amendment No. 2 does not change the budget total;
17 and

18 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY
19 2017 Department of Public Safety Tohono O'odham Police Department West
20 Valley Resort Budget Amendment No. 2 and recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2017 Department of Public Safety Tohono O'odham Police Department West
23 Valley Resort Budget Amendment No. 2 which will adjust operational line items,
24 create new line item 7500 Major Capital and add new language within the
25 justifications.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
27 Nation chairperson or any designated official is authorized to administer and
28 expend the FY 2017 Department of Public Safety Tohono O'odham Police
29 Department West Valley Resort Budget as amended, provided however, that any
30 amendments or modifications shall be submitted for prior approval by the
31 Tohono O'odham Legislative Council.
