

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Public Safety Tohono O'odham Nation
Police Department 638 Law Enforcement Budget Amendment No. 2)

RESOLUTION NO. 17-187

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Department of Public Safety Tohono O'odham Nation Police**
8 **Department 638 Law Enforcement Budget in the amount of \$4,362,007.53 was**
9 **approved by Resolution No. 16-326; and**

10 **WHEREAS, the Department of Public Safety Tohono O'odham Nation Police Department 638**
11 **Law Enforcement Budget Amendment No. 1 was approved by Resolution No. 17-**
12 **017, and decreased the FY 2017 Department of Public Safety Tohono O'odham**
13 **Nation Police Department 638 Law Enforcement Budget by \$10,244.40 from**
14 **\$4,362,007.53 to \$4,351,763.13; and**

15 **WHEREAS, the Tohono O'odham Nation Police Department has prepared and submitted for**
16 **review and approval its FY 2017 638 Law Enforcement Budget Amendment No. 2,**
17 **which is incorporated by this reference and which will adjust operational and**
18 **personnel line items which adjusts the indirect cost charges; and**

19 **WHEREAS, the FY 2017 Department of Public Safety Tohono O'odham Nation Police**
20 **Department 638 Law Enforcement Budget Amendment No. 2 will decrease the**
21 **Tohono O'odham Nation Police Department FY 2017 638 Law Enforcement Budget**
22 **by \$37,771.24 from \$4,351,763.13 to \$4,313,991.89; and**

23 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees have reviewed the**
24 **FY 2017 Department of Public Safety Tohono O'odham Nation Police Department**
25 **638 Law Enforcement Budget Amendment No. 2 and recommend its approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
27 **FY 2017 Department of Public Safety Tohono O'odham Nation Police Department**
28 **638 Law Enforcement Budget Amendment No. 2 which includes a decrease of the**
29 **indirect cost charges by \$37,771.24 changing the overall budget amount from**
30 **\$4,351,763.13 to \$4,313,993.89.**

31 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
32 **Nation chairperson or any designated official is authorized to administer and**
33 **expend the FY 2017 Department of Public Safety Tohono O'odham Nation Police**
34 **Department 638 Law Enforcement Budget as amended, provided however, that**

any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH day of MAY, 2017 at a meeting at which a quorum was present with a vote of 2,816.8 FOR; 204.6 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
