

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Education Child Care and Development Fund-
Discretionary Budget Amendment No. 1)**

RESOLUTION NO. 17-193

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the U. S. Department of Health and Human Services, Administration for
8 Children and Families has awarded the Tohono O'odham Nation a Child Care
9 Development Fund Grant for fiscal year 2017 to implement Child Care Services
10 through the Department of Education, Division of Early Childhood
11 Development; and

12 **WHEREAS,** the Department of Education FY 2017 Child Care and Development Fund
13 Mandatory & Discretionary Budgets were approved by Resolution No. 16-338;
14 and

15 **WHEREAS,** the FY 2017 Notice of Grant Award dated November 1, 2016 reflects an increase in
16 the Child Care Development Fund-Discretionary Allotment; and

17 **WHEREAS,** the Department of Education, Child Care Services has prepared and submitted
18 for review and approval its FY 2017 Child Care and Development Fund-
19 Discretionary Budget Amendment No. 1, which is incorporated by this reference
20 and which will (1) adjust operational line items; (2) increase the FY 2017 Child
21 Care and Development Fund-Discretionary Budget by \$79,784.00 from
22 \$561,733.00 to \$641,517.00; (3) adjust the indirect cost to a 15% cap; and

23 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
24 reviewed the FY 2017 Department of Education Child Care and Development
25 Fund-Discretionary Budget Amendment No. 1 and recommend its approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
27 FY 2017 Department of Education Child Care and Development Fund-
28 Discretionary Budget Amendment No. 1, which will (1) adjust operational line
29 items; (2) increase the FY 2017 Child Care and Development Fund-Discretionary
30 Budget by \$79,784.00 from \$561,733.00 to \$641,517.00; (3) adjust the indirect cost
31 to a 15% cap that shall be funded via reimbursement from the Grantor.

32 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
33 O'odham Nation chairperson or any designated official is authorized to
34 administer and expend the FY 2017 Department of Education Child Care and
