

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Chukut Kuk District Budget Amendment No. 1 and the FY 2017
Tecolote Community Budget Amendment No. 1)**

RESOLUTION NO. 17-196

1 **WHEREAS, Pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **"No District shall expend district funds except pursuant to budgets authorized**
4 **under resolutions of the district council and approved by the Tohono O'odham**
5 **Council. The management of these funds shall be only by a treasurer or other**
6 **authorized officer of the district council who has furnished a surety bond**
7 **satisfactory to the treasurer of the Tohono O'odham Nation and all expenditure**
8 **of these funds shall be by checks signed by such treasurer or other authorized**
9 **officer and the chairman or vice chairman of the district council"**

10 **; and**

11 **WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 16-465**
12 **Approving FY 2017 Chukut Kuk District Budgets; and**

13 **WHEREAS, FY 2017 Chukut Kuk District Budget Amendment No. 1 was approved by Chukut**
14 **Kuk District resolution No. 2017-09, which is incorporated by this reference and**
15 **which (1) incorporates additional language in the budget justification and (2)**
16 **creates line items: 620.01-FICA; 620.02-Leave; 620.03-Workers Comp; 620.04-**
17 **Unemployment Expense; 620.05-Employer Health; 620.06-Employer Dental;**
18 **620.07-Employer Life Insurance; 620.08-Employer Long Term Disability; and**
19 **620.09-Employer Short Term Disability not included in the original budget; and**

20 **WHEREAS, FY 2017 Tecolote Community Budget Amendment No. 1 was approved by Chukut**
21 **Kuk District Resolution No. 2017-06 incorporated by this reference which**
22 **increases line items 650-Tuition and Registration, 865-Other Emergency and**
23 **creates line item 852-Donation/Contribution; and**

24 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2017 Chukut Kuk**
25 **District Budget Amendment No. 1 and the FY 2017 Tecolote Community Budget**
26 **Amendment No. 1 and recommends its approval.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
28 **approves the FY 2017 Chukut Kuk District Budget Amendment No. 1 adding**
29 **\$13,066.09 from FY 2016 Mining Royalties and \$1,104.95 from FY 2016 surplus**
30 **funds increasing the overall budget from \$1,864,094.73 to \$1,878,265.77.**

31 **BE IT FURTHER RESOLVED that this amendment incorporates FY 2017 Tecolote Community**
32 **Budget Amendment No. 1 which increases line items 650-Tuition and**
33 **Registration, 865-Other Emergency and creates line item 852-**
34 **Donation/Contribution.**

7 **day of MAY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
8 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
9 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
10 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
11 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
12 **(48 Stat.984).**
