

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Fiscal Year 2017 San Lucy District Budget Amendment #1 for
Maintenance Program)**

RESOLUTION NO. 17-199

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approval by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council

11 ; and

12 **WHEREAS,** the FY 2017 San Lucy District Budget in the amount of \$2,988,486.42 was
13 authorized by San Lucy District Council Resolution No. SL 09-102-16 and approved
14 by Legislative Council Resolution No. 16-517; and

15 **WHEREAS,** by San Lucy District Council Resolution No. SL 03-44-17 San Lucy District has
16 prepared and submitted for review and approval its FY 2017 Maintenance
17 Program Budget Amendment #1, which is incorporated by this reference and
18 which (1) decreases and increases personnel and operational line items; (2)
19 reclassifies Maintenance Part-Time Worker to a Maintenance Full-Time Worker;
20 and (3) creating new line items 7015 Uniforms, 7060 Food, 7665 Client Support;
21 and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY2017 San Lucy District
23 Budget Amendment #1 for Maintenance Program and recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 FY2017 San Lucy District Budget Amendment #1 for Maintenance Program as
26 attached with no change to the overall budgeted amount.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2017 San Lucy
28 District Budget as amended shall be managed and expended in accordance with
29 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the
30 Nation's laws, provided that any amendments or modifications shall be
31 authorized under District Council resolution and submitted for prior approval by
32 the Tohono O'odham Legislative Council.
