

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Pisinemo Community Budget Amendment No. 1)**

**RESOLUTION NO. 17-202**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,  
3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the Tohono  
5 O'odham Council. The management of these funds shall be only by a treasurer  
6 or other authorized officer of the district council who has furnished a surety  
7 bond satisfactory to the treasurer of the Tohono O'odham Nation, and all  
8 expenditures of these funds shall be by checks signed by such treasurer or other  
9 authorized officer and the chairman or vice chairman of the district council.

11 **WHEREAS,** the FY 2017 Pisinemo District Budgets in the amount of \$2,178,486.42 was  
12 authorized by Pisinemo District Council Resolution 16-P-27 and approved by  
13 Tohono O'odham Legislative Council Resolution No. 16-462; and

14 **WHEREAS,** by Pisinemo District Council Resolution No. 17-P-10 the Pisinemo District has  
15 prepared and submitted for review and approval its FY 2017 Pisinemo  
16 Community Budget Amendment No. 1 which is incorporated by this reference  
17 and which (1) increases the budget by \$8,848.95 of FY 2016 carryovers of gaming  
18 revenues; (2) increases Operational line items; and (3) adds new language to 650-  
19 Tuition and Registration and 7675-Education Assistance; and

20 **WHEREAS,** the FY 2017 Pisinemo Community Budget Amendment No. 1 will increase the  
21 overall Community Budget from \$24,500.00 to \$33,348.95 which will increase the  
22 overall Pisinemo District Budget from \$2,178,486.42 to \$2,187,335.37; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2017 Pisinemo  
24 Community Budget Amendment No. 1 and recommends its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
26 FY 2017 Pisinemo Community Budget Amendment No. 1, which will (1) increase  
27 the budget by \$8,848.95 of FY 2016 carryovers of gaming revenues; (2) increase  
28 Operational line items; and (3) adds new language to 650-Tuition and  
29 Registration and 7675-Education Assistance.

30 **BE IT FURTHER RESOLVED** that this Amendment will increase the overall Community Budget  
31 from \$24,500.00 to \$33,348.95 which will increase the overall Pisinemo District  
32 Budget from \$2,178,486.42 to \$2,187,335.37.






