

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Ge Oidag Community Budget Amendment No. 1)

RESOLUTION NO. 17-205

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,
3 "No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the Tohono
5 O'odham Council. The management of these funds shall be only by a treasurer
6 or other authorized officer of the district council who has furnished a surety
7 bond satisfactory to the treasurer of the Tohono O'odham Nation, and all
8 expenditures of these funds shall be by checks signed by such treasurer or other
9 authorized officer and the chairman or vice chairman of the district council"
10 ; and

11 **WHEREAS,** Tohono O'odham Legislative Council did pass Resolution No. 16-470 approving
12 the budgets submitted for Fiscal Year 2017 for Sells District Administration and
13 it's communities; and

14 **WHEREAS,** Ge Oidag Community has prepared and acquired approval of the attached
15 budget amendment No. 1 and it's justifications with Sells District Council
16 Resolution No. SD-87-17; and

17 **WHEREAS,** Ge Oidag Community has prepared and submitted for review and approval its FY
18 2017 Budget Amendment No. 1 which is incorporated by this reference and
19 which (1) increases and decreases Operational line items; and (2) changes 7675
20 Scholarship and Tuition line item title to 7675 Education Assistance; and

21 **WHEREAS,** the Budget and Finance Committee of the Tohono O'odham Legislative Council
22 has reviewed the Budget Amendment and recommends its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves FY
24 2017 Ge Oidag Community Budget Amendment No. 1 as attached.

25 **BE IT FURTHER RESOLVED** that this amendment does not affect the approved overall Sells
26 District FY 2017 budgeted amount of \$2,178,486.42, nor will it affect the overall
27 FY 2017 Ge Oidag Community Budget.

28 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the
29 District Chairperson and any designated District Official to expend and
30 administer the budget as attached, provided that any modifications or
31 amendments affecting the funds or funding levels of the budget shall be
32 submitted for further prior approval by the Tohono O'odham Legislative
33 Council.

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH
2 day of MAY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-
3 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
4 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
5 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
6 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
7 (48 Stat.984).
